HOUSING PROGRAMS - AS LEAD AGENCY FOR THE HOUSING RESOURCE CENTER SERVING THE ENTIRE MID COUNTY, WE PROVIDE DIRECT RENTAL ASSISTANCE AND CASE MANAGEMENT SERVICES TO INDIVIDUALS AND FAMILIES WHO ARE HOMELESS OR AT IMMINENT RISK OF BECOMING HOMELESS. WE PROVIDE RELOCATION AND STABILIZATION SERVICES, HOUSING SEARCHES, OUTREACH TO LANDLORDS, SAFETY PLANNING, CREDIT REPAIR COUNSELING AND LEGAL SERVICES REFERRALS. IN THE PAST YEAR THIS PROGRAM HAS SERVED 950 PEOPLE IN 520 HOUSEHOLDS AND PROVIDED OVER \$475,000 IN DIRECT FINANCIAL ASSISTANCE. ALL OF OUR PROGRAMS ARE WELL COORDINATED SO WE ARE ABLE TO ADDRESS THE MOST CRITICAL NEED OF THE MAJORITY OF OUR CLIENTS - SAFE AND STABLE HOUSING. HOUSING WORKSHOPS AND HOUSING ASSISTANCE SERVICES ARE A KEY COMPONENT OF ALL OUR PROGRAMS.

ALL RESIDENTS ARE PROVIDED WITH THREE MEALS A DAY, SHOWERS AND LAUNDRY FACILITIES AS WELL AROUND THE CLOCK STAFFING TO ENSURE SAFETY.
